Margaret A. Wheatley, PhD, John M. Reid Professor Department of Biomedical Engineering



Dr. Wheatley received her undergraduate degree in chemistry and a master's in biochemistry, from Oxford University, UK. Her PhD in Chemical Engineering was from University of Toronto, Canada. She completed post-doctoral research with Dr. Robert Langer at MIT, then after three years in industry (advanced drug delivery group at Glaxo Smith Kline), joined Drexel faculty. Her research interests include cancer detection and treatment through development of novel contrast agents for diagnostic ultrasound, pulsed and triggered drug delivery systems, and *ex vivo* gene therapy for spinal cord repair. Her laboratory is an eclectic mix involving polymers in the design of stabilized microbubbles, *in situ* ultrasound-triggered generation of drug-loaded nano particles for solid tumor chemotherapy, the development of multi-modal theranostics and development of multi-

functional constructs for spinal cord repair. She particularly values unique solutions that devolve from the interplay of ideas that develop from the diverse research topics in her lab.

He has published more than 60 peer-reviewed scientific articles and is the author of the *Encyclopedia of Seashells* (1992). In 2012, he was president of the American Malacological Society. He serves on the editorial boards of several journals and is a Commissioner for the International Commission of Zoological Nomenclature, for which he chairs the editorial committee. He teaches courses in Evolution, Evolutionary Ecology, and Systematic Biology, and has previously taught Invertebrate Paleontology.

Dr. Reynolds grew up in Chicago, which has long been an immigrant-receiving city, and one in which questions of race and ethnicity, inequality, geography, and access to power are always in the air. Recently, she joined a research project that looks at violence against women as a global phenomenon. Jason Orne is an Assistant Professor of Sociology at Drexel University and urban ethnographer of sexuality, especially queer enclaves and communities. His work brings these communities' lessons on the power of carnality—the sensual, erotic, and worldly pleasures that guide much of human action—to sociology's embodiment and spatial turn. As a scholar-artist, Dr. Orne brings artistic techniques in creative nonfiction to develop theoretical language with scientific rigor grounded in ethnography's materiality. As a methodologist, Orne works in multidisciplinary teams with medical, public health, and engineering colleagues to use rigorous sociological qualitative methods within their fields' research. He has developed new training methods for large-scale qualitative projects, as

well as analytical techniques that combine qualitative with quantitative and clinical data.
